SUMMARY:

Assists and participates in the maintenance of the golf course; supervises the maintenance and repair of equipment and irrigation system. Responsible for the completion of special projects; and does other related work as required.

ESSENTIAL DUTIES AND RESPONSIBILITIES include the following:

- Assists and plans with the Golf Course Superintendent, the maintenance practices of all turf areas; assists with schedules and assists with supervision of the Associates and use of equipment.
- Instructs equipment operators on the operation and care of mowing and other equipment.
- Assists in chemical and fertilizer applications under the instruction of the Golf Course Superintendent or Spray technician.
- Participates and supervises the operation and maintenance of pumps, and in the maintenance of irrigation and drainage systems.
- Assists in personnel management and evaluation, associate safety, personnel discipline and may also modify the daily work schedule based on the needs of the facility.
- Assists in preparing purchase orders, inventory control and ensures accurate ordering of equipment/parts and replacement equipment/parts.
- Assists in schedules and supervises maintenance work to achieve the most effective utilization of workers and equipment.
- May serve in the capacity of Golf Course Superintendent in his/her absence.
- Reviews and makes recommendations and suggestions to hire, suspend, transfer, promote, evaluate, discipline and terminate all Maintenance Operator Associates in a fair and equitable manner.
- Performs other duties as assigned.

REQUISITE QUALIFICATIONS:

Education and/or Experience: High school diploma or general education degree (GED) required.

Two (2) or four (4) year degree in Turf Grass Management, certificate in Turf Grass Management, or related field a plus. Must have a least two (2) years of experience in golf course maintenance. Experience as a lead operator, spray tech, or irrigation tech is a plus.

Must be able to obtain state pesticide applicators license within 90 days of hire.

Qualifications: Working knowledge of the maintenance practices of the golf course area; the planting cultivating, pruning, and catering for plants, shrubs and trees; the characteristics and proper use of various fertilizers and soil conditioners; herbicides and pest control methods and materials; drainage control methods; and irrigation wells, pumps and automatic controls.

Must apply for, be granted and retain a valid Tribal Gaming License and State Gaming Certification during their employment with Paragon Casino Resort. Must have understanding of and abide by all regulations as stated in the Tribal-State Compact.

Ability to schedule and supervise maintenance work to achieve most effective utilization of workers and equipment; to prepare clear and concise reports; and to maintain effective employee and public relations.

Language Skills: Ability to read, analyze, and interpret written instructions, schedules and diagrams. Must be able to write clear and concise correspondence. Phone communication skills must be excellent.

Mathematical Skills: Ability to add, subtract, multiply, and divide in all units of measure, using whole numbers, common fractions, and decimals.

Reasoning Ability: Ability to define problems, collect data, establish facts, and draw valid conclusions. Ability to interpret and define instructions.
